THE UNDERSIGNED HEREBY ESTABLISHES THE FOLLOWING FOR CHIEF AND BECOMING A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDACHIEN AND UNDER THE PROVISIONS OF THE STATUTES OF THE STATE ALL APARTUAL PROVIDING FOR THE FORMATION, LIABILITY, RIGHTS, PRIVILEGES AND IMMUNITIES OF A CORPORATION FOR PROFIT.

ARTICLE I
