#### ARTICLES OF INCORPORATION

OF

#### CHRISTIAN KOVATS, D.O., P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of this corporation is:

### ARTICLE II. NATURE OF BUSINESS

The corporation may engage in the practice of medicine permitted under the laws of the United States and of the State of Florida.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be as follows: Ten Thousand (10,000) shares of common stock having a par value of \$1.00 per share. #### ARTICLE VII. DIRECTORS
