FOR A STOCK CORPORATION**

The undersigned hereby subscribes to these Articles of Incorporation and executes the same for the purpose of becoming a Stock Corporation for profit under the laws of the State of Florida.

**ARTICLE I
CORPORATE NAME**

The name of the corporation is **SPACE SYSTEMS SUPPORT, INC.**, with its principal office at 8680 N. Atlantic Avenue, P.O. Box 1630, Cape Canaveral, Florida 32920.

**ARTICLE II
CORPORATE NATURE**

This is a corporation for profit and may engage in any activity which is lawful under the laws of the State of Florida, including, but not limited to space launch support, construction and management.

**ARTICLE III
DURATION**

The term of existence of this corporation is perpetual.

**ARTICLE IV
CAPITAL STOCK**

Amendment to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote.

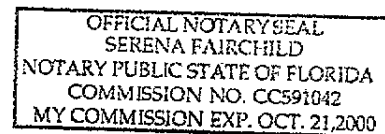
