ARTICLES OF INCORPORATION
OF

IRVCO TRANSPORTATION SERVICES, INCORPORATED
(F.S. 607.0202)

We, Christopher V. Barnwell and Vincent T. Barnwell, the undersigned, subscribe to these articles of incorporation to form a corporation for profit under the laws of the state of Florida.

ARTICLE I. Name

The name of this corporation shall be IRVCO TRANSPORTATION SERVICES, INCORPORATED.

ARTICLE II. Street Address

The street address of the initial principal office is 5358 214th Court South, Boca Raton, Florida 33486.

ARTICLE III. Shares

The corporation is authorized to issue one thousand shares

of stock at a par value of one dollar per share.

ARTICLE IV. Initial Registered Office and Agent

1. Initial Registered Office:

4. Drawing of By-Laws:


The stockholders shall have the responsibility and authority to draw the by-laws.

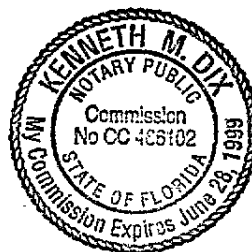


