#### ARTICLES OF INCORPORATION

OF

## BUBBIE BOBKA'S BAKERY, INC.



The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I

The name of this corporation is **BUBBIE BOBKA'S BAKERY, INC.** It's principle place of business is located at 5028 NW 95 DRIVE, CORAL SPRINGS, FLORIDA 33076.

#### ARTICLE II

#### DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date these are filed by the Secretary of State.

#### ARTICLE III

#### PURPOSE

The purpose of the corporation is to perform any and all activities, any ownership of operations necessary to lawfully conduct a retail sales business and to lawfully conduct any other business in the State of Florida, the United States and other parts of the world.

#### ARTICLE IV

#### CAPITAL STOCK

## Section 4.1: Authorized Capital

This corporation is authorized to issue 100 shares (one hundred) of \$1.00 (one dollar) par value common stock which shall be designated "Common Stock". This corporation is not authorized to issue perferred shares. This corporation can issue additional shares upon approval of the Board of Directors.

## Section 4.2: Restrictions on Transfer of Stock

The shareholders may, by By-Law, Provision or by Shareholder's Agreement recorded in the Minute Book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they see fit.

# Section 4.3: Approval of Shareholders Required for Merger

The approval of a majority of the Shareholders of this corporation to any plan of merger or consolidations shall be required in every case, whether or not such approval is required by law.

#### ARTICLE V

PREFERENCES, LIMITATION, AND RELATIVE RIGHTS

OF SHARE OF COMMON STOCK

#### Section 5.1 Dividends

The holders of record of the common stock of this corporation shall entitled to dividends at such times as the corporation is authorized to pay dividends.

# Section 5.2 Rights Upon Liquidation of Dissolution

In the event of any voluntary or involuntary liquidation, dissolution or winding up of this corporation, the holders of record of the outstanding common stock shall be paid from the remaining assets of this corporation ratably.

### Section 5.3 Voting Rights

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common stock.

#### ARTICLE VI

#### DESIGNATION OF SERIES

There shall exist no series in the issuance of the common stock authorized herein.

#### ARTICLE VII

#### PREEMPTIVE RIGHTS

Every Shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the first right to purchase his pro rata share (as nearly as may done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VIII

#### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 5028 NW 95 Drive, Coral Springs, Florida 33076, and the name of the initial registered agent of this corporation at that address is Myra Levine.

#### ARTICLE IX

#### INITIAL BOARD OF DIRECTORS AND OFFICERS

This corporation shall have one (1) Director initially. The number of directors may be increased from time to time by the By-Laws, but never be less than one (1). The name of the initial Director of this corporation is Myra Levine.

#### OFFICERS

The initial Officer is Harriet Grossman, President.

#### ARTICLE X

#### INCORPORATOR

The name and address of the person signing these Articles is: Myra Levine, 5028 NW 95 Drive, Coral Springs, FL 33076.

#### ARTICLE XI

#### BY-LAWS

The initial By-Laws of this corporation shall be adopted by the Directors. The By-Laws shall be adopted, altered, amended or repealed form time to time by either the Shareholders or the Board of Directors, but the Board of Directors shall not alter, amend or repeal any By-Law adopted by the Shareholders if the Shareholders specifically provide that such By-Law is not subject to amendment or repeal by the Directors.

#### ARTICLE XII

#### COMPENSATION

The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directorsm, and to fix the basis and conditions upon which such compensationshall be paid. Any Directors of the corporation may also serve the corporation in any other capacity and receive compensation therefore in any form.

#### ARTICLE XIII

#### INDEMNIFICATION

This corporation shall indemnify any Officer or Director or any former Officer or Director, to the full extent permitted by law.

#### ARTICLE XIV

#### AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the Shareholders is subject to this reservation.
