

ARTICLES OF INCORPORATION

OF ANDREWS & GUY, INC.

ARTICLE I. CORPORATE NAME

The name of this corporation is: ANDREWS & GUY, INC., where the principal office is: 5009 Gall Blvd., City of Zephyrhills, State of FLORIDA, 33541.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The aggregate number of shares which this corporation shall have authority to issue is 2,500, shares of common stock having a NON Par value per share.


