To Whom It May Concern:

On June 2003, International Access Group retained Lawrence J. McGuinness to assist them in reinstating their corporation. The corporation was involuntarily dissolved because International Group did not receive its annual report.

Mr. McGuinness sent International Access Group's check to the Department of State in the amount of \$150.00 but may not have submitted the reinstatement application. Subsequently, a rejection letter was sent to International Access Group advising them to submit the reinstatement application. The rejection letter was forwarded to Mr. McGuinness to further handle the matter which, for the same reason, was not finalized.

When International Access Group Corp., retained our firm to handle another matter, our office conducted a corporate search and discovered that the corporation was dissolved. International Access Group was not aware that the corporation was dissolved.
