**ARTICLES OF INCORPORATION  
OF  
MARLIN COMMUNICATIONS, INC.**

I, the undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby make, subscribe, acknowledge and file this certificate for the purpose of becoming a corporation for profit under Chapter 607 of the laws of the State of Florida.

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation is:

**MARLIN COMMUNICATIONS, INC.**

**ARTICLE II**  
**PURPOSE**

The nature of the business and the purpose for which this corporation is organized to conduct, engage and transact in any or all lawful activities or business permitted which are necessary, suitable or convenient for the accomplishment of the foregoing purposes or which are incidental thereto or connected therewith and to conduct business and carry out all of the aforestated purposes in any state, territory, district or possession of the United States, to the extent not forbidden by law: to have any and all rights, powers and privileges, which are or may be granted, to such corporations incorporated under the laws of the State of Florida.

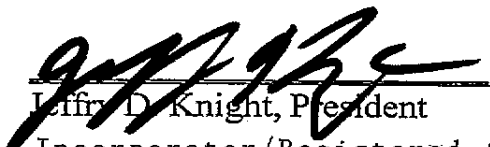
