ARTICLES OF INCORPORATION OF

WILLIAMSON PRESSURE CLEANING, INC.

The undersigned subscribed to these Articles of Incorporation, a natural person competent to contract, hereby executes and assents to the within Articles of Incorporation for the purposes of forming a corporate body under and by virtue of the laws of the State of Florida, and specifically under and by virtue of Chapter 607 Florida Statutes, as amended.

ARTICLE I NAME OF CORPORATION AND MAILING ADDRESS

ARTICLE II DURATION

Any director of the corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled corporation without regard to the fact that he or she is also a director of such subsidiary or controlled corporation.
