The undersigned subscriber to the articles of incorporation, JEFFREY F. JONES, who is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

Name

The name of this corporation is ALPHA_Z MOTORBOATS LIMITED, INC.

ARTICLE II.

Term of Existence
