The name of this Corporation shall be as follows:

SABRA MOVING & STORAGE, INC.

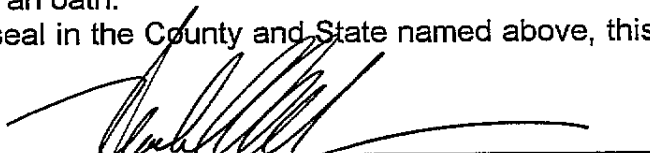

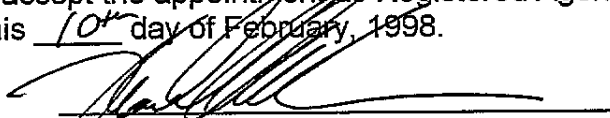
