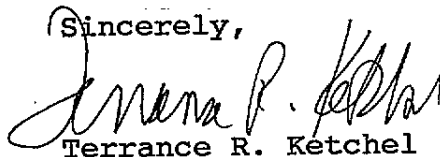

ARTICLES OF INCORPORATION
FOR
AMWEST FLORIDA HOME INSPECTIONS INC.

Article I.

Corporate Name

The name of this corporation is AMWEST FLORIDA HOME
INPSECTIONS INC.

Article II.

Nature of Business and Powers

The general nature of the business to be transacted by this
Corporation is to engage in any and all business permitted under
the laws of the State of Florida.

Article III.

Term of Existence

This Corporation shall have perpetual existence commencing
upon filing of these Articles of Incorporation.

Article IV.

Capital Stock

The maximum number of shares of stock that this Corporation is
authorized to issue and have outstanding at any one time is One
Thousand (1,000) shares of common stock having a par value of One
Dollar (\$1.00) per share.

Article V.

Pre-Emptive Rights

Every shareholder, upon the sale for cash of any new stock of
this Corporation of the same kind, class or series as that which he
already holds, shall have the right to purchase his pro rata share

thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

Article VI.

Registered Agent and Initial Registered and Principal Office

The name of the initial registered agent and the street address of the initial registered office and principal office of this Corporation in the State of Florida shall be: Randall Griffith, 209 W. Miracle Strip Parkway, Unit G-305, Mary Esther, Florida 32569.

The Board of Directors from time to time may move the registered office to any other address in the State of Florida.

Article VII.

Board of Directors

This Corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

Article VIII.

Initial Director

The name of the initial director of this Corporation and his street address is: Randall Griffith, 209 W. Miracle Strip Parkway, Unit G-305, Mary Esther, Florida 32569.

The person named as initial director shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

Article IX.

Incorporator

Article X.

Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholder's meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

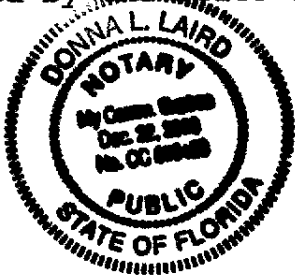
