ARTICLES OF INCORPORATION

ARTICLE I

NAME AND ADDRESS

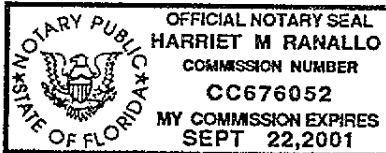


