

**ARTICLES OF AMENDMENT  
OF  
ARTICLES OF INCORPORATION OF  
PERDECK CHIROPRACTIC ENTERPRISES, INC.**

1. The name of the Corporation is Perdeck Chiropractic Enterprises, Inc.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:
