The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is STILLWELL, VAN HORN & ASSOCIATES, INC. and its principal office and mailing address is 3014 Estrella Street, Suite 100, Tampa, Florida 33629.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on March 3, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock
