

subject to this reservation.

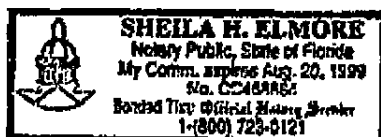


