THIRD ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SYNERGISTIC FRAMEWORKS, INC.

The undersigned Corporation, in accordance with the Florida Business Corporation Act and its Bylaws, hereby adopts the following Third Articles of Amendment:

FIRST: The Corporation's name is:

SECOND: The Corporation amends in its entirety Section A of <u>Article 7-Corporate Capitalization</u> of its Articles of Incorporation, as amended, to provide an increase in the number of authorized shares of Series A Preferred Stock from 500,000 to 680,000, as follows, and there shall be no change in the features of the Series A Preferred Stock as set forth in Section B of <u>Article 7-Corporate Capitalization</u>:
