**ARTICLES OF INCORPORATION  
OF  
CHAMPAGNE INC.**

In compliance with requirements of F.S. Chapter 607, the undersigned Gina Ollivier and Ruth Ollivier being a natural person does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**


