ARTICLE XIAMENDMENT

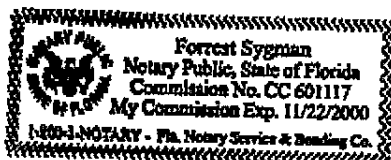
