ARTICLES OF INCORPORATION

OF

M & N SERVICES, INC.

The undersigned subscriber to these Incorporation, each a natural person competent to contract, hereby associates themselves to form a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation is M & N SERVICES, INC.

ARTICLE II.

The general character of the business to be transacted by this Corporation is: electrical contracting firm

To acquire by purchase, lease or otherwise, lands and interest in lands, and to own, hold, improve, develope and manage any real estate so acquired, and to erect or cause to be erected any lands owned, held or accepted by the Corporation, buildings and other structures, public or private, with their appurtenances and to manage, operate, lease, rent, rebuild, enlarge, alter or improve any buildings or other structures, now or hereafter erected on any lands so owned, held or occupied, and to encumber or dispose of any lands, or interest in lands, and any building or other structure, at any time owned or held by the Corporation.
