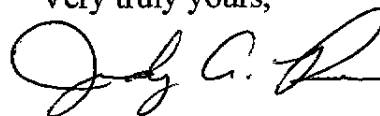

**ARTICLES OF INCORPORATION
OF
MR. ROOTER OF LEE COUNTY, INC.**

The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Mr. Rooter of Lee County, Inc., and the address of the principal office and mailing address of the Corporation is 2323 Del Prado Boulevard, Suite 7, Cape Coral, Florida 33990.

ARTICLE II

Corporate Purpose

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 1,000, all of which are to be voting common stock having a par value of \$1.00 per share.

ARTICLE IV

Registered Office and Registered Agent

Commencement of Existence

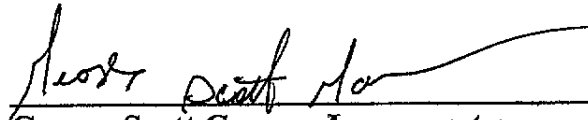
The Corporation shall be deemed to commence on the date of execution of Articles of Incorporation.

Duration

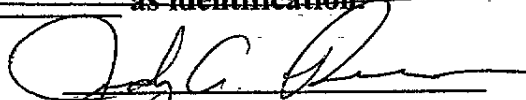

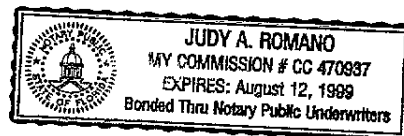
