The undersigned incorporator, for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE 1
NAME.**

INITIAL REGISTERED AGENT AND OFFICE.**

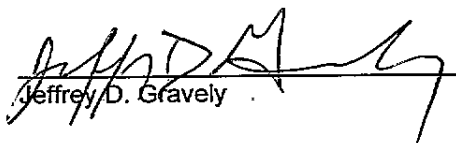
