# ARTICLES OF INCORPORATION ANITAMIT, INC.

THE SOURCE STATE OF THE PARTY O I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.
