ARTICLES OF INCORPORATION

OF

DESTINIES SERVICE, INC.

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is **DESTINIES SERVICE, INC.** (The "Corporation").

2. The principal office of the Corporation is **227 North Magnolia Avenue, suite 101, Orlando, Florida 32801.**

3. The Aggregate number of shares which the Corporation is authorized to issue is 100 shares of Common Stock, par value \$1.00 per share.

4. The street address of the initial registered office of this Corporation is **227 N. Magnolia Avenue, Suite 101, Orlando, Florida 32810** and the name of the initial registered agent of this Corporation at that address is **Gregory Thomas.**

5. The name and address of the person signing these Articles of Incorporation as incorporator is **Gregory Thomas, 227 N. Magnolia Avenue, Suite 101, Orlando, Florida 32801.**

6. The Corporation shall have three Directors initially. The number of Directors may be increased or diminished from time to time, by the bylaws, but shall never be less than three.

INDEMNIFICATION

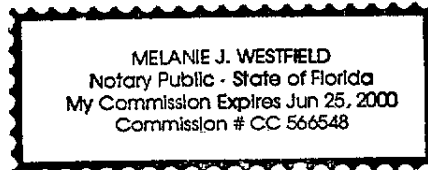
