**ARTICLES OF INCORPORATION  
OF  
A1A SKATEBOARDING CO., INC**

The undersigned subscriber to these Articles of Incorporation is a natural person competent to the contract and hereby forms a corporation for profit under chapter 607 of the Florida Statutes.

**ARTICLE 1 - NAME**

The name of the Corporation is A1A SKATEBOARDING CO., INC.

**ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE 3 - PRINCIPAL OFFICE**

The address of the principal office of this corporation is 452 Willow Run, Lakeland Fl 33813.

**ARTICLE 4 - INCORPORATOR**

The name and street address of the Incorporator of this corporation is:

**ARTICLE 5 - PRESIDENT**

The initial president of the corporation shall be Jeremy Donald Toole whose address shall be the same as the principal office of the corporation.

**ARTICLE 6 - CORPORATE CAPITALIZATION**

6.1 The maximum number of shares that this corporation is authorized to have outstanding at any time is THREE THOUSAND (3000) shares of common stock, each having the par value of ZERO DOLLARS (\$.00).

6.2 No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature; provided, however, that the board of directors may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the board of directors may deem advisable in connection with such issuance.

6.3 The board of directors of the corporation may authorize the issuance from time to time of shares of its stock of any class, whether now or hereafter authorized, or securities convertible into shares of its stock of any class, whether now or hereafter authorized, for such consideration as the board of directors may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in the bylaws of the corporation.

6.4 The board of directors of the corporation may, by the articles supplementary, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or condition of redemption of the stock.

**ARTICLE 7 - "S-CORPORATION"**

The Corporation may elect to be an S Corporation, as provided in Sub-chapter S of the Internal Revenue Code of 1986, as amended.

7.1 The shareholders of this corporation may elect and if elected, shall continue such election to be an S corporation as provided in Sub-Chapter S of the Internal Revenue Code of 1986, as amended, unless the shareholders of the corporation unanimously agree otherwise in writing.

7.2 After this corporation has elected to be an S-Corporation, none of the shareholders of this corporation, without the consent of the other shareholders of this Corporation shall take any action, or make any transfer or other disposition of the shareholders' shares of stock in the Corporation, which will result in the termination or revocation of such election to be an S Corporation, as provided in Sub-chapter S of the Internal Revenue Code of 1986, as amended.

7.3 Once the Corporation has elected to be an S Corporation, each State of stock issued by this Corporation shall contain the following legend: "The shares of stock represented by this certificate cannot be transferred if such transfer would void the election of the corporation to be taxed under Sub-chapter S of the Internal Revenue Code of 1986, as amended."


**ARTICLE 8 - TERM OF EXISTENCE**

The Corporation shall have perpetual existence.


**ARTICLE 9 -- REGISTERED OFFICE AND REGISTERED AGENT**
