**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF TRANSPORTES ARGENTA INC.**

Pursuant to the provisions of chapter 607, Florida Statutes, the undersigned corporation adopted the following Amendments to its Articles of Incorporation:

The undersigned corporation being TRANSPORTES ARGENTA INC. a Florida corporation, the Articles of Incorporation of which became effective on March 6, 1998, resolves that the Articles of Incorporation be, and the same are hereby amended in the following particulars.

1. ARTICLE I "Name" is hereby amended to read as follows:

The name of the corporation shall be EXPORT CARGO, INC.

The foregoing amendment of the Articles of Incorporation were approved and adopted by the stockholders of the Corporation at a meeting of the stockholders held on the August 26, 2002, at which a quorum was presented and the amendment received at least an affirmative vote of the majority of the stock entitled to vote thereon.
