**ARTICLES OF INCORPORATION
OF
J.C.S. IMAGE CENTRE, INC.**

ARTICLE I

NAME

The name of the corporation shall be J.C.S. Image Centre, Inc.

ARTICLE II

GENERAL NATURE OF BUSINESS

This Corporation is authorized to carry on and license and authorize others to carry on all or any part of the several business enumerated in this Article, including all of the following:

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida, and further, without limitation, may conduct all phases of business and all matters relating in any way to such activities. The corporation may also develop, subdivide, and resell real property for profit, and may purchase, sell and otherwise deal in and with, in any manner whatsoever, all types of property, real, personal, fixtures, equipment and all varieties of inventory, supplies and other types of commerce.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of the stock the corporation is authorized to have outstanding at any one time is ONE HUNDRED(100) SHARES with a par value of ONE(\$1.00) DOLLAR per share.

ARTICLE IV
INITIAL CAPITAL

The amount of the capital with which this corporation shall begin business shall be not less than One Hundred Dollars (\$100.00)

ARTICLE V
CORPORATION EXISTENCE

The corporation shall have perpetual existence, which shall commence on the day on which these Articles are subscribed and acknowledged, unless the Articles are not filed with the Department of State within five(5) days thereafter, in which case existence shall commence upon filing.

ARTICLE VI
PRINCIPAL OFFICE

The principal office and place of business of this corporation shall be located at 361 River Chase Drive, Orlando, Florida with the privilege of establishing offices and places of business at other places in the State of Florida or the United State of America or abroad.

ARTICLE VII
DIRECTORS AND OFFICERS

The first Board of Directors of the corporation shall consist of two(2) members as follows

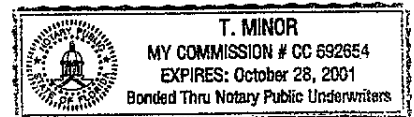
