**ARTICLES OF INCORPORATION
OF
STEINHART HEALTH QUEST, P.A.**

The undersigned incorporators, each of whom is licensed or otherwise legally authorized to practice the profession of medicine in the State of Florida, associate themselves with the intention of forming themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles incorporation for the corporation:

ARTICLE I

NAME

The name of the corporation is **STEINHART HEALTH QUEST, P.A.**

ARTICLE II

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 3659 South Miami Avenue, Suite 4006, City of Miami, County of Dade, State of Florida, 33133. The name of the initial registered agent of the corporation, located at that office, is Corklin R. Steinhart.

ARTICLE III

DURATION

The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders.

ARTICLE IV

PURPOSE

The purpose of the corporation is to practice the profession of medicine. The sole and exclusive professional service to be rendered by the corporation is medicine.

ARTICLE V

CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 10,000 shares. These shares shall be of a single class of common stock, and shall have no par value.

ARTICLE VI

CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporation by the laws of the State of Florida.

ARTICLE VII

INCORPORATORS

DIRECTORS


