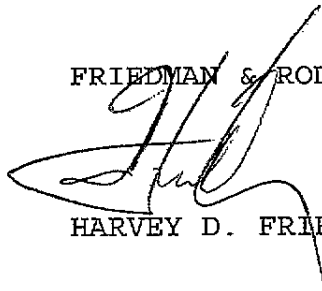

CERTIFICATE OF INCORPORATION

OF

BERNARDO SAVARIEGO M.D.P.A.

THE UNDERSIGNED hereby petitions for the formation of a CORPORATION under the laws of the State of Florida, with and under the following charter:

ARTICLE I

The name of this corporation shall be BERNARDO SAVARIEGO M.D.P.A.

ARTICLE II

This corporation is formed to carry on and conduct the practice of medicine and surgery under the laws of the State of Florida; provided, however, nothing in this act or in any other provisions of existing law applicable to corporations shall be interpreted to prohibit such corporation from investing its funds in real estate, mortgages, stocks, bonds or any other type of investments, or from owning real or personal property necessary for the rendering of professional services.

ARTICLE III

The capital stock of this corporation shall consist of One Hundred (100) shares of common stock of \$5.00 par value each, all or part of said stock to be issued from time to time as may be determined by the Board of Directors. On dissolution or liquidation of the corporation, the holders of the stock shall be entitled to distribution ratably as their holdings may appear upon the stock record of the corporation.

ARTICLE IV

The amount of capital with which this corporation will begin business will not be less than FIVE HUNDRED (\$500.00) DOLLARS.

ARTICLE V

This corporation shall have perpetual existence.

ARTICLE VI

The post office address of the principal office of this corporation until otherwise determined by the Stockholders or Board of Directors, shall be 9117 S.W. 87th Ave, Miami, Fl 33176 Florida, and branch offices may be maintained at such other places in the State of Florida as may be from time to time authorized by the Stockholders or Board of Directors of this corporation.

ARTICLE VII

The business and property of this corporation shall be managed by a Board of Directors consisting of one or more, not to exceed three(3) members, as may be provided by the bylaws.

ARTICLE VIII
