ARTICLES OF INCORPORATION OF G.C. SPENCER & ASSOCIATES, INC.

The undersigned subscriber to these Articles of Incorporation, George Spencer, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is G.C. SPENCER & ASSOCIATES, INC. The principal office and mailing address of the corporation is 27030 Pine Avenue, Bonita Springs, Florida 34135.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK
