ARTICLES OF INCORPORATION FOR BEACH ACCOMODATIONS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the Articles of Incorporation.

(Name and Mailing Address)

> ARTICLE II (Duration)
