## ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of SOUTHWEST FLORIDA EQUITIES CORPORATION, a corporation organized under the Florida Business Corporation Act, hereby affait the following Articles of Incorporation:

- 1. <u>NAME</u>. The name of the corporation shall be SOUTHWEST FLORIDA EQUITIES CORPORATION.
