**ARTICLE ONE - NAME**

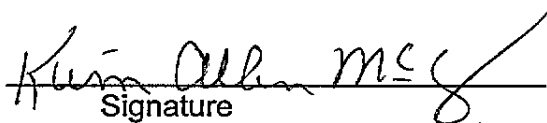
**ARTICLE SEVEN - BOARD OF DIRECTORS**
