**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of **EXCEL CABLE ACQUISITION CORPORATION**, pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**


