ARTICLES OF AMENDMENT
OF THE ARTICLES OF INCORPORATION OF
CABLEMASTERS ACQUISITION CORPORATION

Pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of CABLEMASTERS ACQUISITION CORPORATION (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is CABLEMASTERS ACQUISITION CORPORATION.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

"The name of the Corporation is NATG Merger Sub, Inc."

THIRD: As no shares of stock of the Corporation have been issued, the foregoing amendment was adopted by consent of the sole incorporator of the Corporation, constituting a sufficient number of votes for the amendment to be approved.
