ARTICLES OF INCORPORATION

OF

The undersigned, subscribers to these Articles of Incorporation are natural persons, competent o contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.
