Mail Theft Senseless

I am absolutely enraged that there are citizens in our community who would stoop so low as to break into our United States drop boxes or mailboxes. I am speaking specifically of the May 18 robbery of mail from the drop box in front of the South Lakeland Post Office.

Friday evening, May 18, I completed addressing my daughter's high school graduation invitations, announcing her completion of studies at Harrison School of the Arts. Between 11:30 p.m. and midnight, I drove to the front of the South Lakeland Post Office to deposit 60 stamped envelopes into the drop box. A week later, I learned that the invitations were stolen, along with her college housing information and other mail.

This is the lowest of the low. What has happened to honesty, integrity, and respect for personal property and the United States mail? Have we no conscience?

Thieves, you have crushed my daughter's spirit and broken her heart. This is a student, who for 11 and a half years has struggled with severe asthma just to complete school, was rewarded by her teachers with the prestigious About Face Award and the Minority Achievement Award. Because of this senseless crime, a young girl's family and friends will never know of her proudest moment — high school graduation.

You have been identified as a victim and/or witness of a crime being investigated by the U.S. Postal Inspection Service. The enclosed photocopies are of items recovered by the Polk County Sheriff's Office incident to the report of a collection box break in on or about May 19, 2002. The Polk County Sheriff's Office case number is 02-084262. These items were turned over to the U.S. Postal Inspection Service for investigation on May 20, 2002. It is believed that these are either items you placed in the outgoing mail or items that were incoming to you.

If this correspondence contains bank account, credit card or other financial information, you should closely watch those accounts, in that individuals sometimes use them to obtain money fraudulently. If your accounts are used, or you know anything relating to the theft of the mail, please contact this office. Copies of all mail recovered bearing your name and address are enclosed. If you mailed other items than those which are referenced specifically in this letter, those items have not been recovered at this time. If personal or business checks are missing, it is recommended that you close the account immediately. If the photocopy enclosed is of the front or back of an envelope, the envelope has not been opened, and the contents remain inside. However, items recovered will not be returned as they are evidence in a criminal matter. All items will be forwarded to the U.S. Postal Inspection Service crime laboratory for fingerprint analysis.

Please **DO NOT** call the Polk County Sheriff's Office. Complete the enclosed questionnaire and return it in the enclosed postage paid envelope. If you have any questions, please call Postal Inspector Linda Walker at (813) 281-5217.

The enclosed brochure **KNOW YOUR RIGHTS** outlines your rights as a victim or witness of a federal crime and contains information that may answer questions or concerns you may have. Should you choose to receive services, please be aware that state compensation programs pay only for expenses related to personal injury and do not cover property that is stolen, lost or damaged. As a rule, compensation
