ARTICLE I - NAME AND LOCATION

The undersigned, acting as incorporator under the Florida Business Corporation Act, adopted the following Articles of Incorporation for BROM WEST Corp.

The name of the corporation is BROM WEST Corp. and the principal office of the corporation is 1857 Thomas Street, Hollywood, Fl 33020.

ARTICLE II - DURATION

The corporation shall be perpetual commencing and effective immediately upon filing these Articles of Incorporation.

ARTICLE III - GENERAL NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all business permitted under the law of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a nominal or par value of One (\$1.00) Dollar per share.

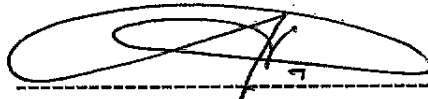
ARTICLES IX - FUTURE AMENDMENTS

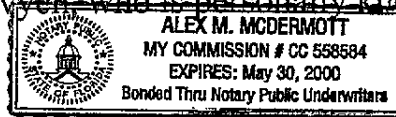

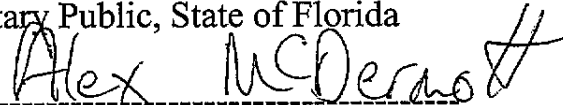
