## ARTICLES OF AMENDMENT TO

### ARTICLES OF INCORPORATION

OF

#### ALLCHEM INDUSTRIES PETROLEUM GROUP, INC.

ALLCHEM INDUSTRIES PETROLEUM GROUP, INC., a corporation organized and existing under the laws of the State of Florida, under certificate number P98000022749 filed in the office of the Secretary of State on March 9, 1998, effective March 5, 1998, hereby certifies as follows:

1. By written action dated the <u>31d</u> day of <u>1998</u>, 1998, the Board of Directors and Shareholders of the corporation unanimously adopted the following resolution:

RESOLVED, that the Articles of Incorporation of ALLCHEM INDUSTRIES PETROLEUM GROUP, INC. be amended so as to change the name of the corporation to ALLCHEM INDUSTRIES PETROLEUM CHEMICALS GROUP, INC., and that the first sentence of Article I shall be amended to read in its entirety as follows:

#### "ARTICLE I - NAME

The name of the corporation is

#### ALLCHEM INDUSTRIES PETROLEUM CHEMICALS GROUP, INC."

2. By written action dated the <u>31d</u> day of <u>Mull</u>, 1998, the Board of Directors and Shareholders of the corporation unanimously adopted the following resolution:

RESOLVED, that the Articles of Incorporation of ALLCHEM INDUSTRIES PETROLEUM GROUP, INC. be further amended to provide that its shareholders shall be afforded preemptive rights, and that a new Article X be added to the Articles of Incorporation to read in its entirety as follows:

#### "ARTICLE X - PRE-EMPTIVE RIGHTS

The corporation shall not issue any additional shares (or securities convertible into shares) of any class, kind or series unless such issuance shall have first obtained the approval of shareholders representing at least eighty percent (80%) of all classes of stock in the corporation which are then outstanding. In the event any such shares should be approved by the shareholders

and issued by the corporation, each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares such shareholder holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days after receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issuance of shares, and inviting such shareholder to exercise such shareholder's preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation."

These Articles of Amendment were approved by all of directors of the corporation and by shareholders representing 100% of the outstanding shares of common stock of the corporation.
