ARTICLES OF INCORPORATION OF INTERNET INTELLIGENCE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is INTERNET INTELLIGENCE, INC.

ARTICLE TWO

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1000 W. Horatio Street, Unit #116, Tampa, FL 33606.

ARTICLE THREE

CORPORATE DURATION

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is upon filing of the Articles with the State of Florida.

ARTICLE FOUR

PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of fleet service and maintenance
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be of a single class, and be without par value.
