ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
WAI-RM, INC.

Pursuant to the provisions of Section 607.1003 and 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: WAI-RM, INC.
2. The Articles of Incorporation are hereby amended by deleting Article I in its entirety and substituting therefor the following:
