WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter mention, and we hereby make, subscribe and acknowledge and file with the Secretary of State of Florida this Certificate of Incorporation; and to that end we do, by this Certificate, set forth the following:

ARTICLE I

The NAME OF THIS CORPORATION is: SANDY'S MASTECTOMY BOUTIQUE TOO, INC.

ARTICLE II

(B) To subscribe for, invest in, purchase or otherwise acquire, to own, hold, sell exchange, pledge or otherwise dispose of securities of every natural and kind, including, without limitation, all types of stocks, bonds, debentures, or obligations or evidences of indebtedness or ownership or participation issued or created by any and all associations, trusts or corporations, public or private, whether created, established under the laws of the United States or any of the States, or any territory or district or colony or possession thereof, or under the laws of any international or foreign country, and also foreign and domestic government and municipal obligations, bank acceptances, commercial paper and secured call loans; to pay for the same in cash or property or by the issue of stock, bonds or notes of this Corporation or otherwise; and while owning or holdings of any securities, to exercise all the rights, powers and privileges of a stockholder or owner, including the right to transfer and convey the said stock or other securities to one or more persons, firms, associations or corporations subject to voting trusts or other agreements placing in such persons voting or other powers in respect of said stock or other securities; to borrow money or otherwise obtain credit and to secure the same by mortgaging, pledging or otherwise subjecting as security the assets of the Corporation.

To design, build, assemble, erect, construct, purchase, hire or otherwise manufacture; to acquire, own, provide, establish, maintain, hold, work, develop, sell, convey, lease, mortgage, exchange, improve and otherwise deal in any products and or real estate, real property and all other kinds of property of whatsoever nature, whether real, personal, mixed, or any interests or rights therein with no limits as to amounts; to buy sell assign, trade, dispose-of, convey and cancel liens upon personal or business property and real estate of every kind and nature whatsoever; to act as broker or agent to purchase, sell, lease and manage real estate, and the negotiating of loans and finances thereon; to borrow and lend money and to negotiate all other loans; to draw, endorse, accept, discount and deliver bills of exchange, promissory notes, bonds, debentures and other negotiable instruments of whatsoever nature.
