INITIAL REGISTERED AGENT AND ADDRESS

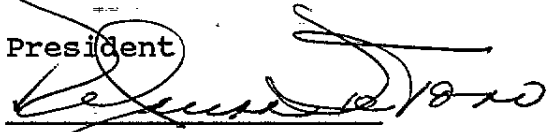
The street address of the initial registered office of the corporation shall be THE SAME as the principal office and the name of the initial registered agent at such mentioned address is MAURA TORO.

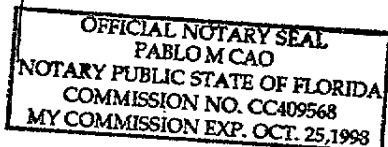
