ARTICLES OF INCORPORATION

OF

LOZIER, THAMES & FRAZIER, P.A.



THE UNDERSIGNED, who desires to form a professional service corporation in accordance with Chapters 621 and 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Lozier, Thames, & Frazier, P.A. Its principal place of business is 125 W. Romana Street, Suite 224, Pensacola, Florida 32501.

ARTICLE II

PURPOSE

The purpose for which the corporation is organized is to practice the profession of law. Additional purposes for which the Corporation is organized are to engage in any and all other activities for which a professional service corporation may be organized in Florida, subject always to limitations of Florida law.
