ARTICLES OF INCORPORATION OF STEPHEN R. MCCASLIN, P.A.

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, do hereby form a professional corporation under the laws of the State of Florida pursuant to Chapters 621 and 607, Florida Statutes, 1996.

<u>ARTICLE I</u>

The name of this professional corporation is:

ARTICLE II

The nature of the business of this professional corporation is any and all lawful real estate business which a professional corporation is permitted to conduct in the State of Florida pursuant to Chapters 621 and 607, Florida Statutes, 1996.

ARTICLE III

The capital stock of this professional corporation shall be 500 shares of \$1.00 par value common stock. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954 as amended by the Small Business Tax Revision Act of 1958.

All of said stock shall be payable in cash, or property other than stock or securities in lieu of cash, at a just valuation to be determined by the stockholders of this professional corporation.

ARTICLE IV

The amount of capital with which this professional corporation will begin business is \$500.00.

ARTICLE V

This professional corporation shall exist perpetually.

ARTICLE VI

The initial registered agent and registered office of the professional corporation in the State of Florida is: Stephen R.

ARTICLE XI

Every stockholder, upon the sale for cash of any new stock of this professional corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
