**ARTICLES OF INCORPORATION
OF
BUMBARA TILE AND MARBLE INSTALLATIONS, INC.**

ARTICLE I. NAME

The name of this corporation is Bumbara Tile and Marble Installations, Inc.

ARTICLE II. PRINCIPAL OFFICE

The initial street address and principal place of business of the corporation is 4541 Dover Street Circle East, Bradenton, Florida 34203.

ARTICLE III. COMMENCEMENT AND DURATION

This corporation's existence shall commence upon the filing of these Articles of Incorporation. This corporation's duration shall be perpetual.

ARTICLE IV. PURPOSE

The purposes for which this corporation is organized are the following:

A. To engage in and transact any activity or business permitted under the laws of the United States and of this state. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them which are not forbidden by the Florida Corporation laws or other law.

C. To engage in the installation of ceramic tile and marble.

ARTICLE V. CAPITAL STOCK

This corporation shall have the authority to issue 100

shares of common stock. There shall be no other class of stock.

ARTICLE VI. PREEMPTIVE RIGHTS

Each shareholder of the corporation shall have the first right to purchase shares (and securities convertible into shares) of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to corporation within thirty (30) days of receipt of notice from the corporation.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The number of directors on this corporation's Initial Board of Directors shall be one (1). The number of directors may be increased from time to time, as provided in this corporation's bylaws, but shall never be less than one (1).

ARTICLE VIII. INDEMNIFICATION

This corporation shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent, to the full extent permitted by law.

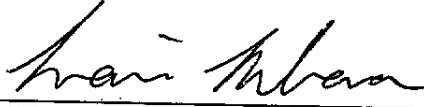

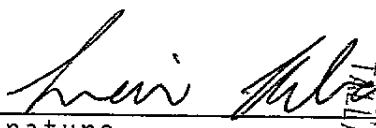
