**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, **TROPIC HEATING & AIR CONDITIONING, INC.**, a Florida profit corporation (the "Corporation"), adopts the following amendment (the "Amendment") to its Articles of Incorporation:

1. The name of the Corporation is **TROPIC HEATING & AIR CONDITIONING, INC.**
2. The Articles of Incorporation were filed on March 11, 1998, and assigned document number P98000023200.
3. Article One of the Articles of Incorporation of the Corporation is hereby amended by deleting it in its entirety and replacing it with the following:

"ARTICLE ONE

The name of the corporation is **CHARLIE'S HEATING & AIR CONDITIONING**, (hereinafter, "Corporation")."

4. This Amendment was adopted on February 26, 2024.
5. This Amendment was duly and unanimously adopted and approved by the shareholders of the Corporation. The number of votes cast for the Amendment by the shareholders were sufficient for approval.
6. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.
