

ARTICLES OF INCORPORATION

OF

KARNHOME, INC.

ARTICLE I

NAME

The name of this corporation is KARNHOME, INC., whose mailing address is 2014 South Andrews Avenue, Fort Lauderdale, Florida 33316.

ARTICLE II

DURATION

This corporation shall have perpetual existence and these Articles are effective upon signing.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

INDEMNIFICATION


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
