ARTICLE ONE

The name of the corporation is D & J ELECTRICAL CONTRACTORS, INC. The principal address of the corporation is: 1107 S.E. 5th Street, Deerfield Beach, Florida 33441

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is 100, at \$1.00 par value.


ARTICLE FIVE

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.


