ARTICLES OF INCORPORATION

OF

We, the undersigned, KENNETH D. ERICKSON and VERONICA ERICKSON, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.
